

CARDIFF, UK: Eco Homes Direct has joined the National Custom & Self Build Association (NaCSBA), to support NaCSBA's work towards making custom and self build a mainstream choice, and to demonstrate Eco Homes' status as a trusted supplier of affordable, low energy engineered timber homes that is in full compliance with NaCSBA's code of conduct.

Eco Homes Direct is unique in the self build sector as its precisionengineered closed panel build system is the UK's gateway to the Canadian Super E® build concept, incorporating a sound approach to

'fabric first' principles and an integrated focus on insulation, airtightness and controlled ventilation to deliver truly affordable, low energy, healthier homes for all.

"It's often difficult for potential self build clients to find the right advice, decide on the best build approach for their project, and work out who will look after them properly," said Eco Homes director Ian Campbell. "We felt we needed an organisation that would give us that credibility and exposure, so we applied to the NaCSBA and after a dialogue and verification process, we were accepted."

"The NaCSBA particularly liked our unique background and experience in using the Canadian Super E® technology and build concept," Campbell added. "This has been adopted worldwide, promoted by the Canadian government's Super E® team, so Eco Homes Direct has the back-up of the best timber frame experts in the world."

Eco Homes Direct has delivered more than 1,000 custom build projects in the UK including over 400 units in affordable housing projects. The system, which offers an affordable alternative to the Passive House concept, is available from manufacturers in South Wales, Berkshire, Gloucester, and Northern Ireland.

NaCSBA believes that the UK should be delivering over 100,000 self build and custom homes a year, while the UK government has put an action plan in place to increase the number of homes built in this way in England to 40,000 per year.

As part of the action plan, the government commissioned the *Independent Review into Scaling up Self Build and Custom Housebuilding* led by Richard Bacon MP, Chair of the All-Party Parliamentary Group on Self-Build, Custom and Community Housebuilding and Place-Making. Updated in July 2023², the report's recommendations include raising awareness of the right to build, promoting greener homes, increasing the use of advanced manufacturing; and introducing planning reforms to support self and custom housebuilding.

Housing and Planning Minister Rachel Maclean MP has confirmed that the government intends to use the updated report to inform its activity around custom and self build as part of its wider housing strategy.

Commenting on the 2023 report, Bacon said: "At the heart of the challenge remains the failure to put the customer at the centre of the new build process. We have created a 'market' where housebuilders compete for land rather than on the quality of the homes that they build; perpetuated in part by an overstretched and under-resourced planning system.

"The consequences are stark. Quite simply, new housing is feared. In no other time in our history would housing be thought of as pollution," Bacon added. To change this, we need to create the conditions in which customers are treated as if they matter the most, rather than – for the most part – scarcely mattering at all."

This approach perfectly aligns with the ethos of Eco Homes Direct and its Super E® programme, which is to put the vision and individual needs of its customers at front and centre.


